

## **UK Funding**

The Woodward Charitable Trust

This is one of the Sainsbury Family Charitable Trusts and is inviting applications from UK registered charities working with or in the areas of:

## Liveable Cities Awards

Electronics giant Philips has launched a new €125,000 worldwide competition for projects that will improve health, quality of life and sustainability in cities. The competition is open to entries from businesses, community groups, NGOs and individuals and projects should fall under one of the following categories:

■ Wellbeing Outdoors - to help citizens feel safe and secure in public spaces, or help create identify and sense of belonging.

■ Independent Living - to help the growing number of elderly people living alone to feel secure and comfortable living in a city, or to enable them to live longer at home while receiving appropriate access to healthcare.

■ Healthy Lifestyle at Work and Home - to support a healthy body and mind, through surroundings or other essentials such as exercise, diet and sleep.

The overall champion will scoop a €75,000 grant, and the two other category winners will each net €25,000. Initial entries must be made by 28 October, shortlisted ideas will be put to a public vote early in 2011, and the winners will be revealed at an awards in April 2011. For more information visit

## Funding for Eco-Innovation Projects

The European Commission has launched a €35 million call for eco-innovation projects to be funded under the Competitiveness and Innovation Programme (CIP). Funding is available for projects in the area of materials recycling, sustainable building products, the food and drink sector, and green business practices, and priority will be given to applications from small businesses. The deadline is 9th September 2010.

### Tudor Trust Grants Programme

The Tudor Trust, one of the largest independent grant making trusts in the UK, has announced new funding guidelines for 2009 – 11. The Trust will continue to make grants for their established funding areas; youth, older people, community, relationships, housing, mental health, substance misuse, learning, financial security and criminal justice. The Trust will also be open to funding work in new areas. The Trust is looking to fund around 350 projects per year for up to three years and will cover core costs, development funding, project grants or capital grants. ### Parks for People

The Heritage Lottery Fund has announced that the next closing date for applications to the Parks for People programme is 31st August 2010. Launched originally as a joint initiative with the Big Lottery Fund full responsibility for the programme has now passed to the Heritage Lottery Fund. Local Authorities as well as not for profit organisations that own public parks and gardens can apply for grants of between £250,000 and £5 million for the regeneration of parks and public gardens (including squares, walks and promenades).

Funding for Individual and Small Groups to Improve their Local Communities

Groups of individuals as well as small community and voluntary groups in the UK that want to improve their communities can apply for funding through the Wakeham Trust. The Trust is interested in supporting neighbourhood projects, community arts projects, projects involving community service by young people, or projects set up by those who are socially excluded. The Trust also support innovative projects to promote excellence in teaching (at any level, from primary schools to universities). The Trust normally gives grants to projects where an initial £75 to £750 can help a project get started. Applicants need to be registered charities or have access to a registered charity that will accept funds on their behalf, and can apply at any time.

Gardening For Disabled Trust

This Trust offers grants to individuals so they may continue to garden, despite advancing illness, age or disability. To apply, individuals must be a member of the Trust's Garden Club and have a written note from their GP, social worker or occupational therapist, describing their disability. The Trust offers a range of support measures such as:

- Adapting private gardens to meet the special needs of the disabled
- Making grants towards tools, raised beds, paving and greenhouses
- Providing help with special gardens in hospitals, centres and schools
- Distributing information on garden aids and techniques
- Providing a forum for disabled gardeners by publishing the Garden Club's magazine.

The Trust's committee meets once a month to consider applications.
