Speaker Biographies



Kath Dalmeny
Chief Executive, Sustain

Kath is Chief Executive of Sustain: The alliance for better food and farming, since 2016 leading the alliance's response to Brexit and its profound implications for healthy and sustainable food, farming and fishing and developing the Campaign for a Better Food Britain.

During the Covid-19 coronavirus pandemic in 2020, Kath has been the alliance lead on Food and Vulnerability, serving on numerous liaison and coordination groups to support the emergency food response at local and national level. She was instrumental with the Good Law Project and Doughty Street Chambers in launching a judicial review of the government's approach to children's holiday hunger during Covid-19.



Stephanie Slater
Chief Executive, School Food Matters

Stephanie Slater is Founder and Chief Executive at School Food Matters. After 20 years working in film production she set up the charity after successfully campaigning to improve the food at her children's primary school.

In 2012 was invited to join the School Food Plan's expert panel, tasked by the Department of Education to create an action plan to help head teachers improve school food. Stephanie is vice-chair of Sustain, a trustee of Alexandra Rose Charity and a member of the London Food Board.



Greg Parsons

Co-Founder, South West Food Hub

Greg's Parsons 35-year career in food and drink has spanned all corners of the sector from hospitality, marketing brands and production and to farming, working for the likes of Whitbread, Unilever and Dairy Crest before joining the boardrooms of SME's. Greg founded Somerset Larder, a collaboration of SME food and drink suppliers who started feeding workers at Hinkley Point in September 2014 spending over £5 million PA with local suppliers.

Greg also set up food supply collaborations in Cheshire and South West England and is working with Larder Cymru to open up more public sector opportunities for Welsh suppliers. As Co-Founder of The South West Food Hub, Greg has most recently helped the setting up of a new social enterprise focussed on implementing Dynamic Food Procurement in the UK.



Rob Percival

Head of Food Policy, Soil Association

Rob Percival is Head of Food Policy at the Soil Association. He leads the organisations advocacy and campaigns for healthy and sustainable diets, with a focus on intensive poultry farming, issues associated with animal feed, and ultra-processed foods.

He also works with the Food for Life programme, lobbying government to improve public procurement policy for schools and hospitals.



Claudia Tarry

Friends of the Earth

Claudia Tarry is an experienced animal welfare, meat reduction and vegan campaigner who previously managed the Meat Free Monday campaign and launched Humane Society International's Forward Food plant-based culinary workshop programme. She has been working with Friends of the Earth on development of its new sustainable catering accreditation scheme, Kale Yeah! Kitchens, which encourages caters to serve less and better meat.



Professor Mike Rayner

Professor of Population Health, University of Oxford

Mike Rayner is the Director of the British Heart Foundation Centre on Population Approaches for Non-Communicable Disease Prevention. His research interests are in public health promotion, including food labelling, food marketing, food taxes and the relationship between a healthy diet and sustainable diet

Mike Rayner is also the chair of Sustain, the alliance for better food and farming in the UK, and Chair of its Children's Food Campaign in the UK. He is a trustee of the UK Health Forum, Chair of the Nutrition Expert Group for the European Heart Network and a member of the Scientific Advisory Panel of the International Obesity Task Force.



Katie Pettifer

Strategy Director, Food Standards Agency

Katie Pettifer is the Strategy Director at the Food Standards Agency. She is responsible for the FSA's strategy, legal, communications and governance work, and for the FSA's "Achieving Business Compliance" programme which is developing smarter ways to regulate the food system for the future.

Katie joined the FSA in July, having previously spent four years as the Public Policy Director at Ofcom, the UK's communications regulator. Before that, she worked in a range of civil service policy roles, covering areas such as the criminal justice system and the Northern Ireland political process.



Paul Irwin-Rhodes

Head of Sustainability, Greggs

Paul is the Head of Sustainability and SHE for Greggs and was heavily involved in the design and delivery of the 'Greggs Pledge', their latest sustainability strategy. As part of their longer term net zero ambition, Paul is currently focussing on their scope 3 analysis and the setting of an SBT to support.



Dr Kelly Parsons

Research Fellow, University of Hertfordshire

Dr Kelly Parsons is a food policy and governance research fellow at the University of Hertfordshire. Her research focus is food systems policies, policymaking processes and governance structures, at global, EU, national and local levels. Kelly has a particular interest in exploring connections in the food system, and efforts to create more integrated and coherent food policy.

She produced the first mapping of government food policy, and is author of a series of accessible briefs on food systems, integrated food policy, policy coherence, and food governance, and 'Connecting Food Systems for Co-Benefits'. She is a European Commission-appointed expert, and has acted as advisor on several food systems research projects. She has a PhD in food policy and a Masters in food and nutrition policy, from the Centre for Food Policy at City, University of London. Before becoming a researcher Kelly worked in food civil society, and as a journalist.



Will Nicholson

Project Lead - Investor Metrics, Food Foundation

Will Nicholson is leading the Food Foundation Plating Up Progress work on food industry metrics for sustainable and healthy diets and the multi-partner initiative to further their uptake with investors and businesses.



Jyoti Fernandes

Campaigns and Policy Coordinator, Landworkers' Alliance

Jyoti is an agrecological smallholder farmer based in Dorset, UK. The farm runs a micro dairy and produces a wide range of products from cheese and meats to cider, juice and preserves.

The farm is part of a local smallholders cooperative that shares collective processing facilities and markets the products of the members' smallholdings collectively. Jyoti coordinates the Policy, Lobbying and Campaigning work of the LWA.



Vicki Hird

Head of Sustainable Farming, Sustain

Vicki Hird MSc FRES is an award-winning expert, author, strategist and senior manager who has been working on environment, food and farming issues for over 30 years. As part- time Head of Sustainable Farming at Sustain, Vicki manages the farm team, policy, research and related campaigning and provides comment and guidance on these issues.

Vicki's new book: Rebugging the Planet, published on 16 September 2021, is a homage to insects and other invertebrates, why they are so essential to our ecosystem and what we can do to help them.



Angela Francis
Chief Advisor, Economics and Economic
Development, WWF-UK

Francis is Chief Advisor, Economics and Economic Development at WWF, providing economic advice across the climate, food and nature programs as well as leading on trade and industrial policy for a green transition. She is a member of UCL's Green Innovation Policy Commission and IPPR's Environmental Justice Commission.



Project Lead (UK cost of the School Day), Child Poverty Action Group (CPAG)

Kate works for the Child Poverty Action Group (CPAG) with a particular focus on understanding the impact of child poverty on education and children's experiences of schooling. Kate oversees research carried out across Great Britain, looking at the best ways to make school life better for children and young people living in low income households. She's been with CPAG since 2018.



Barbara Crowther

Campaign Coordinator, Children's Food Campaign, Sustain

Barbara joined Sustain in 2018 and manages the Children's Food Campaign, which champions children's rights, parent power and government action to improve the food environment children grow up in. This includes campaigning for tighter regulations of junk food marketing to children, better school food and reducing children's consumption of sugary or unhealthy food.

Barbara worked for over 13 years for the Fairtrade Foundation as Director of Policy & Public Affairs, leading the organisation's communications, public campaigning, policy and research to make trade work better for farmers and workers in Africa, Asia, Latin America and the Caribbean.



Ruth Westcott

Campaign Coordinator, Climate Change and Nature, Sustain

Ruth co-ordinates Sustain's work on the Climate and Nature Emergency and on Sustainable Fishing, working to make food a central part of policies to tackle the climate and nature emergency at a local and national level; also to encourage businesses to adopt a fully sustainable fish policy, and thereby help transform the way the world's oceans are fished.

Ruth has led campaigns at Sustain for over seven years, joining from the Marine Stewardship Council. She is a graduate of the University of Oxford and Imperial College, London, where she was awarded the Fishmongers' Company Scholarship.



Liz O'Neil
Director, GM Freeze

Liz O'Neill is the Director of GM Freeze, the UK umbrella campaign challenging the use of genetic modification in food and farming. A comms expert and veteran environmental campaigner with a Biochemistry degree, her work focuses on preventing a corporate-led, high-tech takeover of our food system.



Ben Reynolds

Deputy Chief Executive, Sustain

Since joining Sustain in 2004, Ben has helped launch the Food Power network and was a founding member of the Sustainable Food Cities network. Most recently he came up with the 50 Fountains Challenge (run in partnership with Refill), born out of the Sugar Smart campaign which he developed with the Jamie Oliver Food Foundation.

He worked with Jamie Oliver's team to get the government to adopt a sugary drinks tax, and set up the award winning Children's Health Fund which piloted the levy with restaurants.



Pete Ritchie
Director, Nourish Scotland

Pete Ritchie is Director of Nourish Scotland and also runs an organic farm in the Scottish Borders. Pete chairs Scottish Environment Link's food and farming group and is a member of the Scottish Government's advisory board on post-CAP farm support.



Peter Fox OBE MS

Member of the Senedd

Peter Fox is the Member of the Senedd for Monmouth and the Welsh Conservative's Shadow Minister for Finance. His 13-year term as Leader of Monmouthshire County Council also saw him play an instrumental role in negotiating and securing the UK's biggest city deal - worth £1.3 billion - for the Cardiff Capital Region, for which he was subsequently awarded an OBE. Mr Fox is also a livestock farmer in Monmouthshire.

In November 2021, Peter's proposal to introduce a new Food (Wales) Bill gained support in the Senedd.



Michele Shirlow MBE

Chief Executive of FoodNI and Board Member TourismNI

Michele is the driver behind Food NI, the membership organisation designed to connect the supply chain through a positive promotional message about Northern Ireland's food and drink.

FoodNI is a membership organisation designed to connect the supply chain through a positive promotional message about Northern Ireland's food and drink. Starting 11 years ago with 6 companies Food NI now represents 450 members who work collectively to ensure the success of the industry and build upon the outputs of Year of Food and Drink 2016. Winner of World's Best Food Destination at World travel market in 2018, and a driver behind Taste the Island, FoodNI's vision is to build a profile as a sustainable food and drink region.



Baroness Rosie Boycott Crossbench peer, House of Lords

Baroness Rosie Boycott is a journalist and publisher. She has edited national newspapers and in 2008 was appointed as the Chair of London Food Board to advise the Mayor of London to help improve Londoners' access to healthy, locally produced and affordable food. This role evolved in 2016 when Rosie was asked to lead the development of a new London Food Strategy which was to help the food system to work better to meet the needs of everyone who lives and works in London.

Rosie is a member of the Food, Poverty, Health and Environment Committee in the House of Lords. She also chairs Veg Power and is a trustee for Food Foundation, Feeding Britain, The Hay Festival and is a patron for School Food Matters.

She writes regularly and speaks all over the world about the role of cities in the food chain and the importance of food in improving health. Since becoming a member of the House of Lords in 2018, she continues to speak about the importance of food in tackling childhood obesity, improving health and putting an end to hunger.



Neil Parish MP

Chair of the EFRA Committee, Conservative MP for Tiverton and Honiton

Neil Parish has been the Member of Parliament for the constituency of Tiverton and Honiton in Devon since May 2010.

Before entering politics, Neil was a farmer in his native Somerset and still lives on the family farm to this day. Prior to entering Parliament, Neil was a Member of the European Parliament for the South West of England and a local councillor.

Neil has served continuously on the Environment, Food and Rural Affairs (EFRA) Select Committee since he was first elected, and as of 2015 was elected Chair of the Committee.



Daniel Zeichner MP

Shadow Minister for Food, Farming and Fisheries, Labour MP for Cambridge

Daniel Zeichner is MP for Cambridge and Labour's Shadow Minister for Food, Farming and Fisheries. Environment Minister. He is also chair of the All-Party Universities Group.

Life-long environmentalist Daniel, has backed the school climate strikers and is an executive member of Labour's national environmental campaign group (SERA), making the case for a shift to a greener tax policy. He is a member of Greenpeace, and he has brought leaders on divestment to speak in Cambridge. He is also a bee fan – he is a passionate Species Champion for the Ruderal Bumblebee, and he campaigns to stop bee-killing pesticides.

Daniel cares about social justice and he is a recognised Living Wage Foundation Parliamentary Champion. He has worked closely with students on the Cambridge University Living Wage campaign and with councillors to make Cambridge a proud Living Wage City.



Deidre Brock MP

SNP spokesperson for Environment and Rural Affairs, Scottish National Party MP for Edinburgh North and Leith

Deidre is MP for Edinburgh North & Leith and SNP Westminster Spokesperson for Environment, Food and Rural Affairs & COP26. She has served on the Scottish Affairs Committee since 2017.

Prior to becoming an MP, she was a City of Edinburgh councillor and Depute Lord Provost, and worked at the Scottish Parliament. She grew up in Western Australia and made Scotland her permanent home in 1996.
