# Spending holidays in good health

SUGAR SMART is a campaign that helps local authorities, organisations, workplaces and individuals to reduce the amount of sugar we all consume.

It's with huge concern that we see Coca-Cola once again using the festive spirit of Christmas to promote sugary drinks to children and the general population.

Childhood obesity figures continue to make for grim reading and show no signs of lowering. The latest figures show that almost 1 in 5 children are overweight or obese when they start primary school and almost 1 in 3 by the time they leave primary school. If we don't take drastic action, half of all children will be overweight or obese by 2020.

This year was marked by a record high number of amputations – more than 8,500 last year, mostly due to type 2 diabetes. This condition is closely linked with being overweight or obese and diets high in sugar can lead to being overweight or obese.

It's with these less festive figures in mind that we ask you to stop promoting sugary drinks during the Coca-Cola "Happy Holidays" truck tour this year and only distribute sugar-free drinks and water to the general public and in particular to children.
